Corporate History

Gas South is the largest retail natural gas provider in the Southeastern U.S. Following the acquisition of Infinite Energy in 2020, Gas South now serves more than 425,000 residential, commercial, industrial and wholesale customers in Georgia, Florida, North Carolina and 11 other states. Gas South is a wholly owned subsidiary of Cobb EMC, one of the country's largest electric cooperatives. Gas South offers simple and straightforward rate plans, outstanding customer service and a promise to give 5% of profits to support children in need.

Gas South's sustained growth and success are attributable to a culture of innovation, collaboration and commitment to the communities it serves. The company has formed alliances with 13 city and municipal partners and three EMCs, offering discounted rates to residents and businesses in these communities. This unique public-private partnership also provides new sources of revenue for communities to use to build parks, expand recreation facilities and support government operations. Gas South also partners with social service agencies to offer affordable natural gas service to credit-challenged customers. In 2008, Gas South began offering a specialized rate option with no down payment that also helped customers rebuild credit. This program was the first of its kind in Georgia and has helped provide natural gas service to tens of thousands of underserved households in the state. In 2020, Gas South launched the OnePrice Plan™, which provides a unique product offering to the Gas South product portfolio and allows customers to pay the same amount each month with no surprises.

Since 2006, Gas South has pledged to give back to the community. In 2017, the company committed to giving 5% of profits to children in need. With each financial gift (and an army of passionate volunteers), Gas South strives to build a community that lifts up every child. Gas South has donated more than \$7.5 million to local non-profit organizations since 2006. That is in addition to the thousands of hours of volunteer work that employees donated to charitable organizations, chambers and industry associations through the "Gas South Cares" volunteer program.

Gas South is also committed to supporting sustainability. To date, Gas South has invested \$17 million in solar energy projects. In 2021, the company launched a new business initiative to support renewable energy projects, with plans to invest at least \$15 million annually over the next three years. By the end of 2023, there are plans to have invested \$50 million toward creating a sustainable future. Additionally, as the state's leading supplier of compressed natural gas for alternative fueled vehicles, Gas South is committed to supporting the growth of compressed natural gas throughout Georgia. Gas South is the supplier for six of the state's seven public CNG fueling stations.

Gas South is also one of the industry's leading participants in business associations across Georgia, demonstrating its support for a strong business climate. Gas South prides itself on being the official natural gas provider for the State of Georgia, the Atlanta Braves, the Cobb Energy Performing Arts Centre and Gas South District. Proud of its growth and commitment to its customers, Gas South looks forward to further engaging the community and living out its purpose to "Be A Fuel For Good".
